Vice Chancellor Message

The revolution in different fields of knowledge which transformed the society in recent years also provided us with an opportunity to forge ahead on a new path with a greater responsibility – to instill in our students a critical judgement and ethical sensitivity, apart from the basic role of awarding them academic qualifications.

The first year at the helm of the University of Gujrat (UoG) has so far been very satisfying for me. A few critical steps in the right direction and everything fell into place, without letting the circumstances take a different trajectory. The University of Gujrat – which is now considered an emblem of higher

education, and rightly so – had 114 research papers published by its faculty members in HEC recognized journals during the reporting year. The reporting period also saw the completion of construction of the Multipurpose Hall. A proposal for the establishment of the Business Incubation Centre (BIC) was also finalized recently. Two UoG sub-campuses were established in Narowal and Rawalpindi as designated colleges of Government of the Punjab.

A major development project titled 'Expansion of University of Gujrat and its allied campuses' was approved by Central Development Working Party (CDWP). The project worth billions of rupees included establishment of new UoG sub-campuses as well as construction of more facilities at Hafiz Hayat Campus.

The UoG is playing a pivotal role with regard to a brighter economic and social future of Pakistan. The basic mission of the varsity being the development of research oriented educational setup for achieving knowledge-based economy to boost socio-economic development of the country, the activities for the purpose are managed by the Office of Research, Innovation & Commercialization (ORIC).

We believe that research in the right direction can help us achieve our sustainable development goals. For this, our researchers need to focus on finding indigenous solutions to the problems facing the local industry. The University of Gujrat has strengthened its ties with the Chambers of Commerce and Industry in the region by signing various MoUs and arranging reciprocal visits so that the local industry could benefit from the ongoing research activities in different UoG departments.

Executive Summary

University of Gujrat (UOG) was established in 2004 by Higher Education Department, Government of the Punjab 12 kms away from the Gujrat city for upholding literacy rate in Central Punjab with the aim to promote quality of education at all levels. The objective of establishing UOG in Gujrat is to modernize the higher education standards at national level. UOG improves the higher education sector by introducing qualitative education with research & development culture in a short span of time. This Annual Report for the year 2014-15 provides key information regarding facts of the university with its vision, mission and goals set to be achieved. Chapter wise details are as under:

Chapter-I reflects the academic activities, which were carried out by UOG in the reporting period. These academic activities designate numerous programs at various degree levels being offered by UOG including marvelous academic achievements, foreign and institutional linkages as well as honours and awards bestowed upon UOG faculty and students in 2014-15.

Chapter-XII portrays financial position of UOG during the identified period for carrying out its academic activities.

Chapter-XIII presents the information of UOG governance and management structure within area of working during the reporting year.

Chapter-XIV exhibits UOG's initiatives and approaches to create and grow financial capital. UOG took several steps for catering its needs through its own sources. More than 70% of its expenditure are debited through its own sources.

Chapter- XV indicates the success of UOG for establishing medical facilities in the shape of Nawaz Sharif Medical College (NSMC) for improving health facilities in Gujrat and also promoting medical education in Central Punjab.



About the University

University of Gujrat (UOG) is a quite young and one of the fast growing public sector leading higher education institutes, which entails wide-ranging innovative research and teaching community. It is also dedicated to the transformative supremacy of edification for fostering greater understanding at national as well as international level to boost innovative research culture.

UOG was established by Government of the Punjab through promulgation of University of Gujrat Act IX of 2004. Accordingly, Government of the Punjab provided funds for the development of physical infrastructure in line of modern era requirements. The key purpose of establishing the university in Gujrat was to improve the educational needs of Central Punjab covering 300 km long region between Rawalpindi and Lahore. UOG also facilitates the people of Sialkot, Gujranwala, Hafiazabad, Jehlum and Mandibhuldin for getting higher education in a convenient way. Since its inception, UOG expanded the circle of higher education and research activities through: i) 01 main campus at Hafiz Hayat including 04 city campuses in Gujrat including one constituent Medical College, ii) 02 Government of the Punjab designated Sub-Campuses at Narowal and Rawalpindi and iii) 02 Sub-Campuses under Public-Private arrangement at Sialkot and Lahore. In addition, ninety three (93) colleges have been affiliated to UOG. The purpose of this affiliation is to strengthen quality teaching and academic standards and produce congenial academic environment for the youth of the region.

Vision

UOG has developed its strategic vision for focusing on quality of education, research and innovative higher learning at national level with collaboration of renowned international prestigious institutes to improve the existing setup for further enhancing the literacy rate. Reiterating its commitment as a 'World Class University', UOG endeavors to teach the young people with modern era tools and techniques to compete globally for easy access to quality education. It believes in an equitable social policy and national veracity.

Mission

UOG has equipped mission in line of its vision to educate the young people in diverse areas of economy, social & scientific policy, science & technology and innovative research for enabling them to compete globally. It also encourages remote area youth for education, particularly females. Its mission is to grow up young people according to global trends of education and research thereby contributing more and more for our country. The mission of UOG is to emphasize and improve higher learning set-ups and to educate the youth of Pakistan with the aim to rise-up literacy rate in order to compete at global level.

Students

Thirty six hundred and fifty five (3655) students were enrolled in various degree programs during the academic year 2014-15 at Hafiz Hayat Campus, UOG including Four (04) City Campuses and a Medical College. Overall, 9708 student are studying at Hafiz Hayat Campus, 8792 students at Four (04) City Campuses and 431 students in Medical College. This increase refers to the successful growth of university, which is attributed to factors such as introduction of new programs, maturity of existing programs, hiring of new faculty for expanding research.

Faculty

In order to offer variety of programs, UOG is enticing leading scholars and researchers in a variety of disciplines. However, most of the university faculty is young and committed to promote research and quality of education according to university's vision and mission. Over 100 Faculty members were recruited during 2014-15 to remove the deficiency in academic departments and streamline the academic work. The total strength of faculty members is 628. This growth is significantly witnessed during the academic year 2014-15.

National and International Linkages

UOG constitutes two (02) Government designated Sub-campuses, two (02) Sub-Campuses under Public-Private Partnership, four (04) City Campuses, one (01) Medical College and has ninety three (93) affiliated colleges. Along with its own campuses and affiliated colleges, UOG endeavors to establish linkages with national and international academic institutes and industry. The key objective of establishing these linkages is to reinforce academic relations, scholarships and job opportunities for the students.

Research

UOG's most distinguishing feature is its emphasis on research. University faculty members published more than 114 research papers in various national and international renowned journals in reporting year.

UOG performs certain principle functions, which are as under:

- Providing basic facilities for higher learning and innovative research according to modern era standards.
- Reassurance of the spreading, improvement, expansion and solicitation of knowledge in a scientific way.
- Delivery of study courses/curricula with wide range of arenas and also carrying out research to meet the needs of indigenous population as well as local market requirement.
- Partaking in public discourse
- Awarding and Conferring of degrees at different levels including BS, MA/MSc MPhil/MS, PhD and also award certificates and diplomas under various arrangements.
- Providing teaching for quality of education with forward-thinking knowledge and enquiry.
- Ensuring University-Industry Linkage for extending innovative research in those areas, which need to be explored.

Chapter-1 Academic Activities

In 2014-15, UOG increased its area of academic activities with the inclusion of two (02) Government designated Sub-Campuses at Narowal and Rawalpindi. All academic activities, i.e. academic programs at various levels are being carried out according to Academic Calendar of the university as approved by the Academic Council. UOG offered more than 100 market based academic programs during 2014-15 at BS, MA/MSc, MPhil/MS and PhD level.

Chapter-2

Research and Development

2.1 R&D: An Overview

- Encouraging and enhancing the University's Entrepreneurial Environment by strengthening university-industry relationship as well as expanding partnerships with public and private sector organizations, not for profit organizations and all other community-based organizations.

ORIC realizes the need to positively contribute in developing R&D and to play its role in transforming the economic focus of the country through strengthening of institution to institution and academia- industrial ties. ORIC is keenly involved in establishing linkages with academia, industry and the community to carry out different projects. Besides this, ORIC has signed a number of MOUs with local and regional industries to provide them industrial solutions along with the innovative ideas. The ORIC performs certain operational activities to support the university, which are as follows:

• Developing and implementing the University's research policy.

• Fund-raising for research.

- Ensuring effective distribution and efficient use of research funds, in line with the priorities identified in the University's strategic plan.
- Setting standards and ensuring effective dissemination of high quality research output.
- Representing the interests of the University.

Chapter-3 Quality Assurance

3.1Impact of Quality Assurance in the University

Quality Assurance and Assessment Process (QAAP) of academic work is a continuous process. The purpose of QAAP is to identify weak areas in academics and also take timely steps for improving those key areas. The impact of this kind of assessment is to help future planning in order to consider several options for accomplishing desirable results. This QAAP is effectively used as a tool to evaluate existing practices of overall academic work through set indicators for knowing the actual strengths and weaknesses of the whole system and to further address key steps for improving the existing conditions by implementing actions.

Higher Education Commission(HEC), Islamabad took a revolutionary step by establishing more than eighty (80) Quality Enhancement Cells (QEC) in public as well as private sector universities under the umbrella of Quality Assurance Setup. This Quality Assurance Agency, HEC through these QECs would actively be ensuring the cause of quality education on the one hand and also continuously helping to implement mandatory educational standards for improving higher learning setups on the other hand. Accordingly, the QEC at UOG is having a dedicated staff with the aim to implement Quality Assurance Mechanisms/Setups in the light of Self-Assessment Manual (SAM) and Quality Assurance Manual (QAM). Now, Impact Assessment is being executed to measure the impact of this activity not only for teaching purposes but also to ensure the quality of refined work in educational field, specifically research. The QAA and QEC are involved in the following procedures for streamlining the educational setup:

- i. Terms and Conditions regarding programs
- ii. Faculty evaluation and its job descriptions producing the required impact.
- iii. Compliance of faculty hiring and its eligibility criteria under specific arrangements, i.e., BS/TTS and FFH.
- iv. Self-assessment exercise at institutional level.

Quality assurance related functions emphasize progressive and positive impact regarding teaching and research at institutional level. Accordingly, numerous assessment methods have been drawn for faculty evaluation. This evaluation mechanism is purely interacted with policy guidelines and quality framework manuals of HEC.

Following are the impacts of the Quality Enhancement Cell.

- Quality Enhancement Cell ensures commitment, satisfaction and expectations of all stakeholders.
- Improves quality through process control.
- Confirms the accreditation of all member councils and HEC.

- Assures the recruiting criteria of HEC.
- Helps in infrastructure and institutional support for good services.
- Arranges workshops, seminars and awareness sessions for quality recruitment.
- Rectifies the weak areas of the University for Faculty Development.
- Evaluates the data statistically and highlights the grey areas to point out the discrepancies.
- Highlights the strategic needs of the departments in terms of sources, process and people.
- Assists the implementation plans and remedial action plans.
- Networks with other association to share the best practices.
- Conducts evaluation of program, faculty and students.

3.2 Quality Enhancement Cell

The words "Quality Enhancement" refer to strengthen, enlarge, advance, uplift or rally prevailing system with its practices to enrich faculty of the University for undertaking teaching scope with its real meaning of certification to further ensure quality standards.

The Quality Enhancement Cell (QEC) at UOG was established on 3rd January 2008 in the phase-III of QEC's Establishment, as per guidelines laid down in Quality Assurance Manual under the umbrella of Quality Assurance Agency (QAA) of Higher Education Commission. The purpose of QEC at UOG was to assimilate the idea of quality education in higher learning with greater levels of globally accepted standards. The foremost emphasis of quality assurance program is constant certified growth of workforce on international standards, self-assessment report and academic inspection including evaluation of academic practices under Quality Assurance (QA) prescribed framework. The central goal of all the activities undertaken by QEC is to emphasize on upgrading of educational standards on the one hand and review the current academic and administrative practices on the other hand. The Vision of QEC at UOG is as under:

"In coming few years, ensuring the UOG amongst the Pakistan's top ranking institutions through establishing highly effective and best practices".

The function of the QEC is to promote quality culture in Higher Education by ascertaining the implementation of quality standards and continuous enhancement of the quality parameters.

The QEC is mainly engaged in compiling the data of all the departments for ranking to be sent to HEC for the evaluation purpose of HEC ranking.

b) HEC Review Panel Visit:

The Higher Education Commission (HEC) is striving for provision of quality education across the country. To improve the quality education HEC planned to arrange Review Panel Visits of degree awarding institutions (DAIs). For the purpose, the QEC made extreme efforts to collect all the required documents from the concerned departments and complete the arrangements for the above said visit.

c) Visits of QEC

QEC randomly visits the departments of constituent and affiliated colleges to ensure the quality and evaluation standards.

QEC at UOG has undertaken the responsibility of quality assurance and enhancement with great commitment and devotion. In order to achieve the set goals of QAA for QECs, Program Assessments and Feedback process have been strengthened and implemented in its true letter and spirit.

Chapter-4

Faculty Development

4.1Faculty Development Programs (MS/PhD Local + Foreign)

UOG faculty comprises of men and women who are not only highly skilled scholars, but also aspiring and self-committed individuals who are persistently engaged in their own research. The faculty members come from across the country and also abroad, bringing with them knowledge and diverse range of research techniques. However, UOG is facing challenges regarding shortage of faculty and also issues pertaining to faculty development. Currently, more than 110 faculty members are holding PhD degree in various fields but this is not satisfactory to carry forward the academic and research activities of the university. Accordingly, Prof. Dr. Zia-Ul-Qayyum, Vice Chancellor took initiative with his arrival in December 2014 for introducing a comprehensive "Faculty Development Program (FDP)" for upgrading and capacity building of faculty members. This policy initiative allowed faculty and staff members to proceed admission in MS/MPhil and PhD programs at UOG with following Terms & Conditions:


- 1) The faculty and staff members shall be allowed to improve their higher education.
- 2) 25% of Academic and Administrative employees of the university in their respective departments shall avail this opportunity at a time.
- 3) No Objection Certificate shall be granted to only those employees who have served on regular basis for at least two (02) years at the university.
- 4) During office workload relaxation shall only be granted subject to the registration of his/her courses.
- 5) Admissions shall be granted according to approved admission policy of the university.
- 6) 50% of the total semester fee shall be waived off.

In addition, UOG is also seeking funding from HEC for sending faculty on MS/MPhil/PhD programs abroad under the project "Strengthening and Expansion of University of Gujrat and its Allied Campuses". This Human Resource Development Plan (HRD) of UOG is envisaged to improve faculty skills, knowledge, utilization of resources and reduction of dependency on external technical support. In future, it will help to produce capable graduates from the university.

5.4 Employability

6.2 New Initiatives

UOG took-up numerous new initiatives to strengthen university-industrial linkages for removing the financial constraints and drawing line of action to encourage economic growth and resource generation. UOG also organized numerous conferences, seminars, workshops, trainings with the collaboration of national and international organizations/ donor agencies/industries for enhancing the university-industrial linkages. Our new economic initiatives are based on innovative philanthropic efforts to enhance fast track university transition of traditional economic structure. Following initiatives have been taken during last year 2014-15:

i. ORIC, UOG proposed to establish a smart Grid in upcoming year, Center of Excellence in Renewable Energy & Energy Efficiency Program (REEEP) for smart metering by exploring sources of PV, BIOMASS, utility and hybrid system. The grid would produce 1MW to fulfill UOG needs.

6.3 Internship and Placement Office Center, UOG

UOG is already committed to provide its students with job placement services. The Student Services Center is the key office to help the students to find an excellent job opportunity according to their career interests and abilities. It offers them an opportunity to interact freely with different companies, organizations, industries and enterprises for employment purposes through several workshops and Seminars. The offices maintain close relationship with industry and business companies.

For placement purposes of the UOG graduates, Career Guidance &Placement office in Student Services Center is proactively establishing relationships with local industry for internships, jobs, scholarships and financial support to needy students. Chapter-7 Strengthening Physical Infrastructure

7.1 Development Projects (Laboratories, Libraries, etc.)

UOG has its own Work Committee and Work Rules, for the execution of development projects regarding civil works through enlisted contractor/firms, approved by the Syndicate in its 17th meeting held on 02.03.2013. All development projects either funded by Government concerned departments or by university's own sources are being executed according to University of Gujrat's (UOG) Work Rules and Punjab Procurement Regularity Authority Rules (PPRA), 2014. These Work Rules are derived from PPRA Rules and Contract Document, C&W Department, Govt. of the Punjab. All the academic requirements are collected from academic departments at the end of each financial year with complete justification. These academic requests are presented to Work Committee with tentative cost estimates for inclusion in the Annual Works Program (AWP) and for onward Transmission to the Syndicate through Finance & Planning Committee. After approval from the competent forum, the approved developmental schemes/projects are executed through university funds as listed in AWP.

During 2014-15, following projects/schemes were taken-up:

1. Establishment of University of Gujrat

The project titled "Establishment of University of Gujrat" was initiated by Higher Education Department, Government of the Punjab in 2006 for establishing university in Gujrat to fulfill the higher educational needs of Central Punjab population. Funds amounting to Rs 3458.358 million were allocated for this project. 80% of the construction work was completed during 2013-14 and the remaining 20% of construction work is planned to be executed during 2014-15 subject to the provision of funds from concerned funding agency. 983 Kanal and 9 Marla's land were designated by Government of the Punjab for this project. Under the umbrella of this project, numerous facilities were constructed, i.e., Seven (07) Academic Blocks, Three (03) Admin. Blocks, Four (04) Hostels, One (01) Canteen, Community Facilities Three (03) Mini Markets, One (01) Mosque, One (01) Guest House, One (01) Female Faculty Accommodation, One Boundary Wall, Residencies for Vice Chancellor, Registrar & Controller of Examinations, Thirty three (33) Grade 18-19 Residencies, Eight (08) Grade 20 Residencies, Eight (08) Grade 15-17 Residencies, Twelve (12) Grade 11-14 Residencies, Twenty four (24) Grade 1-10 Residencies, Two (02) Overhead reservoir and internal Roads.

2. Establishment of Nawaz Sharif Medical College(NSMC) & Uplifting of ABS (DHQ) as Teaching Hospital

Government of the Punjab took a historic step in the direction of full scope of essential Health Care Facilities in Gujrat area. The Chief Minster, Punjab issued directions to establish "Nawaz Sharif Medical College, University of Gujrat" in September 2008. The PC-I of project titled "Establishment NSMC & Uplifting of ABS (DHQ) as Teaching Hospital" was approved by PDWP in its meeting held on 2009 and accordingly Pakistan Medical & Dental Association (PM&DC) recognized the college. Rs 1974.246 million are allocated for this project. The project comprises one (1) Faculty Hostel, forty (40) Faculty Apartments, Twenty (20) Faculty Residences, three (03) Student Hostels, Boundary Wall, two (02) Clinical Blocks at ABS, twenty (20) bedded Ward emergency at ABS (64 bedded each), one (01) Operation Theater at ABS, roads and landscaping. Presently, the work is in progress and almost 65% is completed.

3. Construction of Multipurpose Hall at University of Gujrat

The project titled "Construction of Multipurpose Hall at University of Gujrat" was approved by Central Development Working Party (CDWP) on 14.03.2012 and funds were provided by Higher Education Commission, Islamabad amounting to Rs 50.250 million in mid of FY 2014-15. Accordingly, the work started and is still in progress and will be completed in 2015-16. The basic purpose of the project is to provide a Multipurpose Conference Hall for arranging academic activities, co-curricular, indoor sports activities and also organizing official meetings, functions, under one roof.

4. Extension of "P" Block, University of Gujrat

The project/scheme titled "Extension of "P" Block, University of Gujrat" was initiated on the request of Architecture Department, UOG with the approval of Work Committee amounting to Rs 99.395 Million through its own sources, i.e., AWP 2014-15 for carrying out academic work and research activities as per standards of Pakistan Council of Architects and Town Planners (PCATP). This project is mandatory for the accreditation of PCATP before proceeding any academic program in the university. During 2014-15, Consultant was hired for Architectural & Structural Designs/ Drawings and top-supervision of the project. The construction work is now being carried out under supervision of Works Department, UOG.

5. Strengthening & Expansion of University of Gujrat and its Allied Campuses

The project "Strengthening & Expansion of University of Gujrat and Its Allied Campuses" was approved by CDWP on 28.04.2015 and Administrative Approval was issued on 13.05.2015 for Rs.2988 million.147 Million including FEC of Rs.135.707 Million with completion time of 36 Months. The two major components are included in this project. First construction component covers missing academic facilities of Hafiz Hayat Campus, Gujrat and the Second construction component designated for the establishment of UOG Sub-Campus at Narowal.

6. Construction of Additional Portion of Central Library, UOG

The work/scheme "Construction of Additional portion of Central Library, UOG" was initiated during the reporting year as per request of the Library Department to provide additional facilities to the disable persons and study and research sections. Twenty two million (22) rupees were allocated for this scheme through university's own sources. The design for this work/scheme was prepared by Director (Planning and Design), C&W Department, Government of the Punjab. The Work/Scheme was executed and completed during the reporting year for Rs 19.00 million with the saving of Rs 03.00 million.

7.2 Research Equipment

UOG provided equipment's to its academic departments during 2014-15 for streamlining the academic work and also executing the research activities as per time-to-time requirements. Detail of department wise research equipment is as under:

Chapter-8 Strengthening Technological Infrastructure

UOG constantly improves and strengthens its Information Technology set-up with the provision of funds from Higher Education Commission (HEC) and Higher Education Department, Government of the Punjab. Currently, UOG has large IT set-up with the focus to support academic work and encourage research activities. Each academic department retains a computer lab for faculty and students. All faculty members have separate computer systems in their respective offices. Senior faculty members have separate laptops. The HEC provided high-speed internet connectivity of 60 Mbs at the Hafiz Hayat Campus for internet connectivity to the students and faculty.

National Digital Library programme was launched by Higher Education Commission of Pakistan (HEC) in February 2004 with the purpose to increase the access to scientific literature in Pakistan. The HEC secured inclusion in the Programme for Enhancement of Research Information (PERI) of the International Network for Scientific Publications (INASP). The Digital Library Office of HEC and National Academy of Science (USA) under their collaborative programme, funded under the Joint Pak-US S&T fund, provide access to Research Journals from well-reputed American Scientific Societies to meet the specific requirements of the research in Pakistani Universities. The programme provides researchers within the public and private universities of Pakistan and non-profit research and development organizations with access to high quality peerreviewed journals, databases, articles and PhD theses across a wide range of disciplines. University of Gujrat is also fully facilitated with access to the HEC Digital Library Programme. Brief introduction of resources available to UOG is as under:


8.3 Video Conferencing Facility



8.4Campus Management Solution

UOG initiated a project related to campus management solution under the umbrella of Software Development Cell (SDC) in accordance with HEC guidelines to facilitate the interaction and communication system with faculty, staff members and students to enhance educational standards. Presently, UOG Information System (UOGIS Academic Module), UOG Alumni portal, UOG faculty and student web portal, UOG OPAC Library system and database management system are the key projects to assist the faculty and students regarding their academic activities. The UOGIS is a comprehensive solution that automates majority of tasks that are required in proper functioning of UOG. The UOGIS has reached advanced stage level campus management solution, which is comparatively more beneficial due to its modalities of stages. UOGIS allows faculty to record attendance, enter sessional marks and upload lecture notes, schedule and any other information they would like to share. Students are permitted to login and see their marks and attendance data as well as the lecture stuff. This facility has made academic activities easy for both—faculty and students. Because of UOGIS, UOG has an advantage over what other universities campus management solutions are offering, in that they are not at the advanced level.

The UOG Alumni portal is another system to actuate the faculty and students on a single forum for social interaction to discuss the academic issues and devise their solutions. Our campus management solution is integrated and acts as management information system, which efficiently deals with the various UOG activities, i.e., faculty & student management, administrative functions etc. It increases the key benefits of students including enhancement of interaction and communication with teachers, the ability for students to meet many regular requirements such as scheduling and verification of attendance without the assistance of a university employee. The campus management solution at UOG is also managed and updated with student academic activities from the stages of admission, examination details, career placement or internships, and alumni relations. The program also provides students and alumni with immediate access in time information regarding events and new developments. It also provides students access to online course selection and registration process with timetable, results and examination schedules. The UOGIS facilitates the students to register themselves for online courses and generate fee challan from anywhere around the world. Lecture sharing with affiliated colleges is also feasible.

The UOG site navigation is designed to be user friendly together with various tools and services to access University's key features such as faculty, departments, disciplines, research and teaching categories, admission details, new developments and all office details with key personnel. All students and faculty are provided with e-mail address and login facility. The UOG web portal provides news updates regarding new developments in UOG on daily basis to the faculty, students and other users.



Chapter-9 Universities Building Communities

9.1 University-Community Interaction

Community interaction as a core function of UOG is to encourage and accomplish enterprises with communities to facilitate cooperation between the university and communities and deliver the means whereby they can dynamically realize knowledge, teach and learn new adding's/areas. UOG strongly distinguishes community interaction related activities from teaching, learning and research, such activities may fulfill following terms and conditions:

- The activity should be interactively associated to an identifiable group in a community outside the institution.
- Collaboration should be actively allied to recognizable needs of both the university and the community. There should be an obviously identified advantage for the community and for the university.
- The interaction should be a sustained action within a reciprocally distinct relationship.

The UOG management supports the combination of three core purposes, i.e. teaching and learning, research and community interaction. In its strategic framework for planning and development of academic promotion and infrastructural development as per UOG Vision, the task of a University is to:

- o create knowledge (research)
- o transfer knowledge (teaching)
- apply knowledge (community interaction)

The Community Interaction Policy affirms the University's commitment to have a relationship with the communities in which it is rooted. The UOG policy endorses the acknowledgement of its contribution for the reduction of illiteracy through several academic initiatives and commitments to redress the developmental initiatives according to community needs.

In support of its mission under selected focus areas, UOG highlighted the important issues and catered community needs on regular basis. UOG undertakes to play a leading role in serving the community and opening up new opportunities for the people of the community who wish to improve their lives. To the successful implementation of these tasks, the UOG Students Services Center (SSC) has chalked out the strategy for community participation to encourage the healthy educational environment. The Center has organized a number of programs for the community's interaction and development, in which local people have also participated. The center engaged the students to organize various literary programs on the shrine of Saint Hafiz Hayat. These programs were beneficial for UOG's sustainable academic development and to interact with people who

participate for the development of UOG through funding and financial grants. UOG adopted two important modalities for community interaction:

- a) Collaboration: Establish collaboration between UOG and Community for achieving mutual objectives and goals.
- b) Social Customs and Developments: UOG conducts research and identifies the society's values and customs for sustainable social development.

UOG established Hayatians Alumni Association of existing & former students and faculty for the community interaction and the achievement of university's desirable goals. The Hayatians Alumni is the supportive forum for interaction between UOG and local area people. The Alumni role is to build UOG's worth within the society for the strengthening of indigenous education.

9.2 University's role in Community Building

UOG has three main roles, namely: Education, Research, and Community Service. The purpose of the community service role is to assist in developing community potential in order to achieve desired societal goals. University research also contributes to societal welfare and developing community potential i.e. excellent research partnerships, industrial-research partnerships and book writing in co-operation with local companies. These services contribute to community development. In this regard, UOG took developmental initiatives including literacy programs, reforestation projects and business incubator development. UOG Student Services Center (SSC) plays a pivotal role in community building. Furthermore, SSC has established three forums for encouraging the role of university in community building. These are Internship & Placement Office, Career Counseling Office and Hayatian's Alumni Association. UOG maintains and builds its relationships with the community in several direct and indirect ways, for example:

- It provides opportunities of higher education to the surrounding communities.
- UOG is the biggest employer of unskilled workers and supports staff living in its vicinity.
- UOG also hires skilled and professional staff from nearby villages and towns.
- UOG Campus FM Radio serves a large population in 50Kms radius. Its programmes offer information, news, and entertaining materials for all kinds of audience.
- UOG has demarcated four Union Councils where students are able to conduct surveys and research with friendly inhabitants. (See SSR below)
- Various departments assign projects and activities to the students that may involve productive and beneficial activities for the community. For example, students of the Development Communication launched a dental education programme in nearby villages.
- Campus FM Radio plans to broadcast programmes for a variety of audience in the communities.
- Presence of over 15,000 students and staff in the city and suburb is changing business landscape of the city and rural Gujrat. New businesses are emerging and a variety of services is mushrooming. These are offering employment opportunities to many in the neighborhood.

With the establishment of Hayatian's Alumni Association, UOG fosters lifelong connections between students and faculty for the development of university academia providing financial and technical assistance for deserving students in the shape of scholarships. On the Alumni forum, University promotes, encourages, and assists in effective communication between faculty and the alumni. Alumni participate in productive activities such as students' recruitment and career development in the broad spectrum of activities. This platform serves to develop strong relationship between Hayatians and UOG for common interests of academics.

9.3 Alumni Affairs: Outstanding Achievements

Hayatians Alumni Association is an association of former students, existing students, faculty and people, who have attained a prominent position in the field of education. The member of the Haytians' Alumni Association represents university within the society as an Ambassador for achieving its desired objectives. The member is a mouthpiece of UOG at social level. The Association consists of two forums: the General Body (GB) and the Executive Committee (EC). The General Body is the supreme authority of the alumni and all the members of the alumni are the part of General Body. The Executive Committee is a forum for implementation of the Alumni's strategy with active and effective mode. The EC is comprised of following twelve members elected by General Body and one member will be nominated by the UOG Competent Authority for two years:

- 1. President
- 2. Vice President
- 3. General Secretary
- 4. Joint Secretary
- 5. Information Secretary
- 6. Secretary Finance
- 7. Executive (Five Members)

There are two types of membership offered by Hayatians Alumni Association

- a. Regular membership
- b. Honorary membership

The major achievement of the UOG Hayatians Alumni Association is to gather all alumni and faculty under one roof, for the benefit of UOG graduates. The Hayatians Alumni Association forum plays a key role in the development of the University and fund raising for deserving students in the form of scholarships. The recent event organized by the Association and UOG brought to the fore the good news that many members of the UOG Alumni had secured excellent positions in the industry and public sector.

Achievements of Hayatians Alumni

The University Alumni have achieved their desired objectives within a short span of time and enhanced the University's academic strength at national level. The Hayatians Alumni Association forum plays a key role in the development of University and fund raising for deserving students in the form of scholarships. Following are the achievements of Alumni in the year 2014-15:

- Organized several events for university-community interaction and promotion of researchbased culture in this region.
- Arranged Alumni Annual Dinner for interaction between students and faculty and announcement of key initiatives.
- A large number of faculty members and students have been registered on the forum of University Alumni.
- Established new links with local communities and industry for working on common interest areas and boasting the socio-economic development.
- Provided career opportunities to university graduates through our internship program and industry internship initiatives.

Chapter-10 Sports

Sports Department, UOG was established in 2007. The Sports Department, UOG provides all essential facilities to the students for physical activities, particularly sport purposes for the wellbeing and healthy grooming of youth. Hundreds of scientific studies and researches across the world have conclusively proved that regular physical activities lead to higher life expectancy and better quality of life by maintaining fitness. Accordingly, Sports Department, UOG provides following facilities/services to their students:

- 1. Provides indoor sports facilities for male & female students such as Badminton, Basketball, Chess, Gymnastics, Karate, Netball, Table Tennis & Weightlifting.
- 2. Provides outdoor sports facilities for male and female students such as Athletics, Cricket, Football, Kabaddi, Volleyball & Tug of War.
- 3. Conducts Annual Sports Gala at each year in which students from UOG Hafiz Hayat Campus, all City Campuses of UOG and all Campuses from other cities participate.

Chapter-12 Finance

Introduction: Office of the Treasurer

Office of the Treasurer is primarily entrusted to manage property, finances and the investments of the university and its funds. UOG fund is comprised of all moneys received in the form of fees, donations, trusts, bequests, endowments, contributions, grants and other sources. Role of the office of Treasurer as Secretariat of Finance & Planning Committee (An Authority under University of Gujrat ACT 2004) includes Financial Planning, advising, executing and reporting of Fund based accounting, i.e., preparing annual and revised budget estimates of University.

The other proprietary role of the office of the Treasurer is to ensure that funds of University are expanded on the purposes for which they are provided. In order to ensure this responsibility, it is authorized to devise a system of internal Audit, its reporting mechanism and enforcement of other effective & efficient checks and balances, internal control measures to avoid/ minimize errors, omissions and inefficiencies.

Moreover, maintaining of prescribed books of accounts/record, presenting it for external audit, preparing annual statement of accounts and reporting it to relevant Authority is the accountancy function assigned under Section 35 of University of Gujrat Act, 2004 services areas of the office of Treasurer are classified as Fee/Receivable Management, account, budget, disbursement, pay roll management, withholding tax agent for Federal & Provincial exchequer, Asset Management, project based accounting, trust fund management etc.

Being part of University administration, Office of the Treasurer is well motivated to contribute its effective role for achieving University's mission/strategic goals and objectives.

12.2 Financial Year at a Glance

The University of Gujrat has received funding from Government of the Punjab for development purposes, whereas Higher Education Commission (HEC) provided funds for development as well as non-development purposes to run the academic affairs smoothly, to maintain quality of education and research culture. The university also generates revenue through its own financial sources in the form of academic, registration & affiliation fees, examination fees (from affiliated colleges), hostel dues and sale of forms. The UOG encourages resource generation with the help of new initiatives and strategies. During the financial year 2014-15, the UOG received Rs 218.874 million from Government of the

Punjab and Rs333.874 million from the Higher Education Commission. These funds were lesser than the UOG's own resources amounting to Rs. 732.572million.

12.3 Development Budget

Government of the Punjab allocated Rs133.610 million for their two ongoing projects at the University of Gujrat, i.e. Establishment of University of Gujrat, Establishment of Nawaz Sharif Medical College (UOG) & Uplifting of Aziz Bhatti Shaheed (DHQ) as Teaching Hospital and Construction of Multipurpose Hall at UOG funded by HEC. Chapter-13 University Governance

In addition to above it was also decided that strict disciplinary action be taken against the Principals concerned, letter of displeasure be written to them and the HED be informed about the negligent behavior of the Principals, (vi) nominated Prof Maqsood Akhter, Principal Punjab College, Jalalpur Jattan, Gujrat as a member to redressal of grievances committee, (vii) award advance increments in accordance with UOG Service Statutes, (viii) decision taken by the Vice Chancellor regarding special examination due to loss of answer sheets, (ix) Conveyance Allowance shall be given to all employees after deduction transportation charges as per Government directions/policy and UOG Service Statutes, (x) special incentives for the UOG employees serving at campuses out of Gujrat with rates, i.e., BPS-16 and below 8,000 PKR per month, BPS-17 to BPS-18 12,000 PKR per month and BPS-19 and above 18,000 PKR per month, (xi) 3% employment quota for disabled persons as per Government notification, (xii) the appointment orders may not be substituted and all new appointees, either their previous services at UOG were confirmed or not, have to observe the probation and it is not necessary that the same be written in the appointment letters, (xiii) to establish the College of Veterinary Science and Livestock Management (as constituent part of UOG), (xiv) the Vice Chancellor and delegated such powers to deal matters regarding full fee refund to the admission applicants in future, (xv) delegate its powers in this regard to the Vice Chancellor under section 22(2) (i) read with section 22(2) (xxvii) of UOG Act IX of 2004 to sanction time barred claims of development and operational expenditure related to previous financial years, (xvi) for establishment of Board of Trustees for SAFE, (xvii) to compensate by the provision of allowances/benefits on meritorious grounds with rates, i.e., Hostel Wardens @ Rs. 10,000/month, Coordinators @ Rs. 6,000/month and Deputy Wardens @ Rs. 5,000/month, (xviii) to the payment of remuneration for performing duty regarding entry test of University of Engineering and Technology, Lahore., (xix) to adopt the Version 2.0 of Model Tenure Track Process Statutes of HEC till formulation and approval of TTS Statutes of UOG, (xx) to appoint the two members for UOG Selection Board, (xxi) to enhance the fee of the students of Nawaz Sharif Medical College, (xxii) the action taken by the Vice Chancellor and delegated

powers in this regard to the Vice Chancellor to waive off the fine against late submission of examination fee, (xxiii) the recommendations given by the Selection Board in its meetings held on 2nd, 3rd, 7th, 27th and 28th March 2015 in exercise of powers vested under Section 22 (2) (xvii) of UOG Act IX of 2004 read with section 7 (1) of the First Statutes (Section 52) of the act ibid, (xxiv) the recommendations of the Affiliation Committee, (xxv) the minutes of the 4th Meeting of Academic Council in appreciation of the powers vested under section 22. (2) (xvi) of 2004.

Further, the Syndicate also discussed six (06) table agenda items, wherein (i) the Syndicate agreed that the Salary of the Principal be revised as proposed above and the case be forwarded to the Chancellor, University of Gujrat through Higher Education Department for final approval and then (ii) discussed the matter of daily wage rates and payment to the staff working on weekends. It was recommended that the issue be settled in such a way that the salary of the employees does not decrease. It was further decided that the Treasurer and the Representative of Finance Department shall propose a solution to resolve the matter amicably and present in forthcoming meeting. In addition, the Syndicate also approved the: (iii) consideration of admission of Fall-2013 as Spring 2014 for PhD program in Department of Chemistry₁ (iv) to regularize the audit Para's, and (v) proposal as stop gap arrangement and recommended to procure a suitable piece of land to construct Camp Offices / Guest Houses in Lahore and Rawalpindi. Lastly, the Syndicate defer the recommendations of the Promotion Board regarding promotion cases of five (05) Assistant Registrars (BPS-17) to the ranks of Deputy Registrars (Bps-18) and 01 Assistant Controller of Examinations (BPS-17) to Deputy Controller of Examinations (Bps-18) for forthcoming meeting.

13.2 Academic Council Meetings

The Academic Council shall be the academic body of the UOG as per provisions of the University Act IX 2004 to regulate the proper standards of academic work, issue instructions for teachers, researchers, publishing of research work (publications), conduct of examinations, affiliated colleges and other academic affairs of the university. UOG Academic Council liable to advise the Syndicate on academic matters for the smooth function of the university academia affairs. The 3rd meeting of the Academic Council was held on 9th September 2014. The Vice Chancellor, UOG presided the meeting. Following agenda items were discussed and approved by the Council:

Chapter-14 Office of Resource Generation/Development

14.1 Initiatives and Implementation

In UOG, the management offices, i.e., the Vice Chancellor, the Registrar, Director (Academics), Director (Planning & Development), Director (Quality Enhancement Cell), Director (Students Services Center), Director (IT Services), Director (A&C), Director (Works), Director (Financial Aid Office) and Director (ORIC) are playing vital role for forming human resource development with consultation of Academic Deans. The Office of the Vice Chancellor and the Registrar Office are the key offices to take-up important decisions to run the university affairs in a better way and maintain conducive working environment. All these offices provide all kind of support to academic Dean Offices for executing their academic work on day-to-day basis and reshaping the academic policies according to modern era requirements. These offices are responsible for defining academic and research rules & procedures, recruitment of faculty & staff, students' academic affairs and liable to guide and implement future initiatives. During 2014-15, UOG took-up following initiatives and also ensured their implementation:

- i. Introduced/started **PhD program** in more than ten (10) disciplines.
- ii. Appointed more than **One Hundred Teaching Members** at various levels for removing staff deficiency and strengthen academic area.
- iii. Established **Financial Aid Office** for providing scholarships to students according to HEC guidelines.
- iv. Granted Affiliation More Than Fifteen (15) Colleges for improving higher education in these colleges.
- v. Strengthened **Students Alumni and extended the Student Societies** for promoting cocurricular activities for healthy learning.
- vi. Initiated process for acquiring 386 Kanal 14 Marla's land adjacent with UOG amounting to Rs 90.00 million for Master Planning of future academic facilities.
- vii. Initiated process for acquiring 136 Kanal11 Marla's land in front of UOG Gate No.1 amounting to Rs198.419 million for the provision of sports facilities for students.
- viii. The Project "Strengthening & Expansion of University of Gujrat and Its Allied Campuses" was approved by Central Development Working Party (CDWP) on 28.04.2015. Accordingly, Administrative Approval of this project was issued on 13.05.2015 for Rs.2988.147 Million. The two (02) construction components are included: (i) Strengthening of University of Gujrat and (ii) Establishment of University of Gujrat Sub-Campus at Narowal. The Consultant hiring process for designing of civil work related items are in process for both construction components.

- ix. The work/scheme "Extension of "P" Block at UOG" was initiated on the request of Architecture Department amounting to Rs 99.00 million through university own sources for academic purposes and fulfillment of accreditation requirements of PCATP. The tendering process for award of civil work was just completed and the work/scheme will be executed in initial days of next financial year, i.e., 2015-16.
- x. The project titled "**Construction of Multipurpose Hall at University of Gujrat**" was approved by Central Development Working Party (CDWP) on 14.03.2012 and funds provided by Higher Education Commission, Islamabad amounting to Rs 50.250. This project was timely identified according to University academic requirements (current as well as future). The work is in progress and will be completed in next financial year, i.e., 2015-16.
- xi. The work/scheme "**Construction of Additional Portion of Central Library, UOG**" was initiated during the reporting year as per request of the Library Department to provide additional facilities to the disable persons as well as to study and research sections. Rs 22.00 million were allocated for this work/scheme through university's own sources.

14.2 Future Plans

UOG is growing rapidly due to increasing number of student's enrollment, infrastructural development and newly launched degree programs in various disciplines. Following initiatives for future planning are as under:

- a) UOG undertakes planning for the expansion of academic infrastructure, 2 to 3 new campuses in different cities, i.e., Narowal, Rawalpindi, Bhakkar, Murree etc. for improving the higher education sector.
- b) Prioritize the projects of research and faculty development.
- c) Construction of faculty residencies and hostels for students.
- d) New Database Center and networking set-up for better IT services.
- e) University of Gujrat will start the UOG-Vice Chancellor's Young Researcher Scholarship Program to articulate and publicize the Vice Chancellor's vision for the promotion of Higher Education in Pakistan.
- f) Plan to install the one Mega Watt Solar Power Plant for domestic energy needs and resource generation through commercial activity.
- g) Prepare strategic plan for UOG for the exigency of the University academia and infrastructural developments. This plan contains the strategies for human resource development and areas of research and development.
- h) Establishment of Business Incubation Centre in next year.
- i) Launch capacity-building program for faculty and staff to improve their skills.
- j) Construction of additional academic facilities, i.e., Labs and Rooms.
- k) Provide Lab equipment's for faculty of engineering and faculty of Arts under the project "Strengthening & Expansion of UOG and its Allied Campuses".

Establishment of Botanical Garden for extending research activities as per requirements of Botany Department.

- m) Start PhD Physics Program from Fall-2015 and Stimulation Lab
- n) Department of Computer Sciences' start of MS (Computer Science) as well as PhD program under faculty development program and also Upgradation of existing and establishing new labs.
- o) Center for Media & Communication Studies is planning TV Studio under the Linkage Program (University of Gujrat-Gaylord College of Journalism & Mass Communication Funded by US State Development.
- p) Center for Languages and Translation Studies (CeLT) has planned to start short term courses/certificates in: Spoken English, English for kids, English for Hotel Staff, IELTS (Preparatory Classes), German Language Goethe-Zertifikat A1, French Language DELF A1, Chinese Language Level 1, Machine Assisted Translation, Fundamentals of Acoustic Phonetics, Spanish Language, Japanese Language, Computational Linguistics Speech Processing, Urdu Computational Grammar, Statistical Language Processing and one year PGD Diploma in Translation Studies.
- q) Procure buses and vehicles for students and employees staff for extending transportation circle.
- r) Extend institutional, foreign and industry linkages for extending research and academic cooperation with innovativeness.
- s) Department of Product Design planned to start Associate Degree in Furniture Design.

Chapter-15 Health Centre/Medical Facilities

15.1 Medical Facilities available at NSMC College

University of Gujrat (UOG) achieved another milestone by establishing the Nawaz Sharif Medical College (NSMC), because medical education, though in high demand, was not available in the industrial triangle prior to its establishment. Realizing inadequate facilities of medical education and quality health services in the industrial triangle, Government of the Punjab took a historic step to revolutionize the health care facilities in Gujrat by establishing the NSMC at UOG in September 2008. The approved project cost is Rs.1974.246 Million, out of which Rs.1284 Million have already been utilized. Now, more than 60% work is completed. Currently, the construction work of one (01) student hostel, twenty (20) faculty houses and female faculty hostel are under progress and will be completed in next financial year.

The classes of MBBS started on 13.04.2009 in one dedicated block of university. During 2014-15, one hundred and eight (108) students enrolled in MBBS program. Four Hundred and ninety one (491) total number of students are studying in MBBS program and 105 faculty members are working in various disciplines of NSMC, UOG. Further, the construction work of Faculty Apartments, two (02) student hostels and two (02) additional blocks at teaching hospital will also be executed in the end of next financial year. NSMC, UOG is playing significant role to improve the standards of medical education at national level and ensure health facilities in remote areas for dealing with patients, who belong to two categories i-e Outdoor cases and Emergency cases. Presently, Seven (07) Basic Medical Sciences Departments and Sixteen (16) Clinical Sciences Departments are operational in medical college. The Pakistan Medical & Dental Council awarded FCPS training for MBBS doctors in various clinical departments. Following are the key facilities available at NSMC, UOG:

A) Heath Care Centre

A Health Care Centre was established at the premises of Nawaz Sharif Medical College, University of Gujrat in 2009. The primary aim of establishing this facility was to provide primary care/treatment to the students, faculty and staff of University of Gujrat. Health Care Centre contains Reception, Medical Inspection Room, Diagnostic Lab and Detention/Treatment Room. Medical officer examines the patients in Medical Inspection Room and advises treatment accordingly. Diagnostic Lab has the facility to carry out routine investigations helpful in diagnosis. Detention/Treatment room is used to detain and treat the patients as per advice of the Medical officer. The Health Care Centre also provides medicines to the patients accordingly. Patients who need consultation/ treatment from concerned specialists are transferred through University

Ambulance to ABS Teaching Hospital where they get treatment or even admission if required. Towards the end of academic year, health care center added a laboratory and ambulance to facilitate the staff and students.

B) Advance Research & Diagnostic Lab at Medical Block UOG

An advanced Research & Diagnostic Laboratory was fully equipped with latest automated analyzers for Diagnostic and Research purposes including Molecular Medicine and Drug Research. This laboratory envisages providing highly advanced and rare diagnostic laboratory tests including molecular diagnostic tests. Advance Research & Diagnostic Lab are providing both general and specialized testing along with integrated academic, scientific and technical research assays. The aim and purpose of this laboratory is to assist researchers of medical field at UOG by providing them high quality diagnostic laboratory testing services. Details of lab facilities areas are as below:

- Physiology Laboratory
- Histology Laboratory
- Pharmacology Laboratory
- Forensic Laboratory
