- 2. A certificate / affidavit that the firm is not defaulter / blacklisted and have not indulged in litigation with any Government Department or Authority / Autonomous Body.
- 3. Certificate of registration with (PEC) and (PCATP) along with the latest renewal letter.
- 4. Copy of Registration with Securities & Exchange Commission or Registrar of Firms.
- 5. Personal details / CVs of qualified professionals in each field on the payroll of the firm or associated with the firm on judicial stamp paper of Rs. 20/- duly certified by Notary Public /Oath Commissioner. The core staff must show their project wise experience with exact time duration for each project.
- 6. Statements of bank accounts for the last three (3) years.
- 7. Copy of registration with Income Tax Department / Sales Tax department and proof of deposited tax for last 3 years.
- 8. Copy of Audited Statement of account for the last 03 years.
- 9. List of five (05) similar assignments completed and five (05) in hand similar assignments by the firm during last ten (10) years, **indicating total cost of such works and cost of consultancy services** received against those works along with date of start and completion or expected date of completion of assignments.
- Financial proposals clearly indicate the cost of services against the required work.
- Complete set of Request for Proposals, instructions for participation including criteria alongwith TORs may be obtained from Directorate of Works, University of Gujrat on payment of Rs. 3000/- (non-refundable) through Bank Draft / Pay Order made in the name of Treasurer, University of Gujrat.
