### Call for Abstracts: Special Edition on Social Prescribing 2026

The Pakistan Journal of Social Issues (PJSI), a multidisciplinary, double-blind peer-reviewed journal published by the University of Gujrat, invites abstract for a forthcoming special edition on social prescribing. This special issue aims to provide a dynamic forum for discourse on social prescribing with potential for application in Pakistan. Emergent and challenging social science research and policy issues, broadly defined under the theme of "Significant Social Issues in Contemporary Pakistan and Beyond."

#### **SCOPE AND THEMES**

We welcome original research articles, scoping reviews, rapid reviews, systematic reviews, randomized controlled trials, metanalysis, meta synthesis, empirical reports, conceptual reviews, opinion pieces, and policy debates from the fields of:

- Social Prescribing in and connected to Pakistan (or the people of Pakistan in any country internationally).
- Social Prescribing and Mental Health in Low-Resource Settings
- Community Health Workers as Link Workers in Social Prescribing
- Social Prescribing for Non-Communicable Diseases (NCDs)
- · Cultural Adaptation of Social Prescribing Models
- · Youth and Social Prescribing: Education, Employment, and Mental Wellbeing
- Social Prescribing for Older Adults and Social Isolation
- · Digital and Mobile Health in Social Prescribing
- Policy, Governance, and Integration into Primary Healthcare
- Gender and Social Prescribing

#### SUBMISSION GUIDELINES

Submissions should address critical questions of social prescribing, social justice, policy alternatives, and the evolving landscape of social sciences and humanities. Authors are encouraged to reflect on their research experiences and discuss how these contribute to a deeper understanding of social prescribing and social issues for the people of Pakistan (or with Pakistan heritage).

- Submission Guidelines
- Abstracts should not exceed 300 words and must clearly state the research question, methodology, key findings, and relevance to the special edition's theme.
- All submissions must be original, unpublished, and not under consideration elsewhere.
- Manuscripts must adhere to the journal's formatting and ethical standards.
- Full papers will be solicited from accepted abstracts.

#### Use of Al to Create Written or Visual Content

Authors should not list a generative AI technology as a co-author or author of any submitted manuscript. Generative AI technologies cannot be held accountable for all aspects of a manuscript and consequently do not meet the criteria required for authorship. If the author of a submitted manuscript has used written or visual content produced by or edited using a generative AI technology, this use must follow all Frontiers guidelines and policies. Specifically, the author is responsible for checking the factual accuracy of any content created by the generative AI technology. This includes, but is not limited to, any quotes, citations or references. Figures produced by or edited using a generative AI technology must be checked to ensure they accurately reflect the data presented in the manuscript. Authors must also check that any written or visual content produced by or edited using a generative AI technology is free from plagiarism. If the author of a submitted manuscript has used written or visual content produced by or edited using a generative AI technology, such use must be acknowledged in the acknowledgements section of the manuscript and the methods section if applicable. This explanation must list the name, version, model, and source of the generative AI technology.

We encourage authors to upload all input prompts provided to a generative AI technology and outputs received from a generative AI technology in the supplementary files for the manuscript.
